

- Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to INSTITUTE OF TEACHER EDUCATION MEERUT - DELHI ROAD , KADRABAD , MODI NAGAR, GHAZIABAD-201201, , UTTAR PRADESH for conducting M.ED. course with an annual intake of 25 students, under clause 7 (12) of NCTE Regulation dated 13th Jan 06 subject to fulfillment of the following :-
 - (i). The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account to be operated along with an official of the Regional Committee.
 - The institution shall comply with the various other norms and standards (ii) prescribed in the NCTE Regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc, wherever applicable.
